Tenderers will be required to register on the website. The Tenderer would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated. Tender documents are also available for information on official website of MRVC www.mrvc.indianrailways.gov.in. However, Tenderer has to submit the offer only on e-procurement website https://eprocure.gov.in.
- 6. For submission of the tender, the tenderer is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities (CAs), authorized by Government of India for issuing DSC. Tenderers can see the list of licensed CAs from the link (www.cca.gov.in). Aspiring tenderers who

have not obtained the user ID and password for participating in e-procurement in this Project, may obtain the same from the website: https://eprocure.gov.in.

- 7. Tenders comprise two Parts, namely the Technical Part and the Financial Part, and both parts must be simultaneously submitted online on https://eprocure.gov.in (website) on or before 12.00 Hrs. of 15-10-2024. Any tender or modifications to tender (including discount) received outside e-procurement system will not be considered. The electronic tendering system would not allow any late submission of tender. The "TECHNICAL PART" of the tender will be publicly opened online on the same day in the presence of the Tenderers' designated representatives and anyone who chooses to attend at the address below at 15.00 hours, and this could also be viewed by the tenderers online. The "FINANCIAL PART" shall remain unopened in the e-procurement system until the second public tender opening for the financial part. If the office happens to be closed on the date of opening of the tenders as specified, the tenders will be opened on the next working day at the same time and venue.
- 8. All Tenders must be accompanied by a Tender Security of the amount specified for the Work in the table below, drawn in favour of "Mumbai Railway Vikas Corporation Ltd." Tender Security will have to be in any one of the forms as specified in the tendering document and shall have to be valid for 45 days beyond the validity of the tender. The tenderers are required to submit (a) original tender security in approved form; and (b) original affidavit regarding correctness of information furnished with tender document, with General Manager (Procurement), Mumbai Railway Vikas Corporation Ltd., Second Floor, Churchgate Railway Station Building, Mumbai 400 020 before the Tender opening deadline given above, either by registered post/speed post/courier or by hand in sealed cover, failing which such tenders will be declared non-responsive, and will not be opened.
