- 1. The Government of India has applied for financing from the Asian Infrastructure Investment Bank (AIIB or the Bank) toward the cost of the **Assam Secondary Road Network Improvement Project (ASRIP)** and intends to apply part of the proceeds toward payments under the contracts detailed in the table below.
